**1. Organizer**

- 1.1 For the organization of the 2010 NORCECA Men's Junior Continental Championship, U-21, the Canadian National Volleyball Federation accepts to comply with the terms and conditions established in these Competition Regulations that are the official statutes of the event.
- 1.2 The Canadian National Volleyball Federation, affiliated to the North, Central American and Caribbean Volleyball Confederation, NORCECA and to the Federation Internationale de Volleyball, FIVB, **will be responsible for the organization of the 2010 NORCECA Men's Junior Continental Championship, U-21**, programmed to be held from August 16-22, 2010, in the city of Gatineau, Canada.

## **3. Statutes & Authority**

### **3.1 Competition Regulations:**

These Regulations will be the statute that controls the competition. Any situation not covered by these regulations will be decided according to NORCECA Regulations and in the contrary by the FIVB Regulations, including its Constitution, Administrative, Sport, Financial, General Regulations, Complementary Statutes and Code of Conduct.

### **3.2 FIVB Official Rules of the Games**

The **2010 NORCECA Men's Junior Continental Championship, U- 21** will be played in accordance with the FIVB Official Rules of the Game in force.

### **3.3 Control Committee**

The competition will be conducted by the Control Committee, which will be designated and appointed by the President of NORCECA Volleyball Confederation.

### **3.4 VISA information:**

In order to facilitate the participation of qualified National Teams in the **2010 NORCECA Men's Junior Continental Championship, U-21**, the Canadian National Volleyball Federation and/or the Organizing Committee must guarantee throughout the correspondent Canada governmental authorities, the entry VISA that will permit the entry of participating team members registered in the FIVB 0-2 Form into Canada.

## **5. Participating Teams & Delegation Composition**

- 5.1 A maximum of Twelve (12) teams will participate in the **2010 NORCECA Men's Junior Continental Championship, U-21**. They are the Top Twelve (12) Teams of the NORCECA Ranking including the AFECVOL, CAZOVA & ECVA Zonal Champions. The following eleven Teams have indicated their intent to participate based on the principle above:

## 5.2 **Team Composition:**

Each team delegation will be composed of a maximum of 19 persons, consisting of:

- Twelve (12) Players
- Four (4) Officials (Head Coach, Assistant Coach, Therapist, Team Manager)
- One (1) Doctor (FIVB accredited)
- One (1) Sports Journalist (FIVB accredited and/or NORCECA)
- One (1) Referee (FIVB, International FIVB, International FIVB Referee Candidate and/or Continental Referee)

## 5.3 **Additional personnel on the teams:**

All person that exceed what is stipulated in Article 5.2 will be considered as additional personnel and the National Federation (NF) that registers them will have to pay for all their expenses including lodging, meals and internal transportation. The names of these persons should be submitted in advance to the Canadian National Volleyball Federation and/or NORCECA, and the National Federation concerned must pay the amount of US\$100.00 daily per person for their registration based on double occupancy or US\$150.00 daily per person in single occupancy. The National Federation (NF) that registers additional personnel shall make the correspondent payment before but not later than the Preliminary Enquiry.

## 6. **Player's Eligibility**

- 6.1 Participating players must be citizens of the country that they represent according to the FIVB Sports and General Regulations.

The official document to verify the player's eligibility is their valid passport, issued by the competent governmental authorities of their country. Each participating National Team, must provide, during the preliminary enquiry, color copies of each players passport.

- 6.2 The passports of all players must be presented to the Control Committee for its verification during the preliminary inquiry. Players whose original passport (no passport copies will be admitted) are not presented during the preliminary inquiry will not be accredited and therefore will not be able to participate in the competition.
- 6.3 Players born on or after January 1<sup>st</sup>, 1991 are eligible to participate in the **2010 NORCECA Men's Junior Continental Championship, U-21.**

## 7. **Registration and participation fees**

### 7.1 **Registration:**

The registration of each National Team will consist in submitting the FIVB O-2 Form to NORCECA Volleyball Confederation together with the payment of the registration fee of US\$750.00 (Seven Hundred Fifty Dollars) before June 10, 2010. Additionally, an Anti- Doping fee of USD\$500.00 (Five Hundred Dollars), per participating team must be paid to cover the Anti-Doping test control to be performed during the competition. For the registration of participating teams the use of the official FIVB O2 form for the event is required. These forms are available to be downloaded throughout NORCECA Confederation web page, [www.norceca.org](http://www.norceca.org).

**7.2 Players final registration (FIVB O-2 bis Form)**

During the Preliminary Enquiry, the Team Manager must submit to the Control Committee the FIVB O-2 bis Form with a maximum of 12 players. In case that the FIVB O-2 bis Form is not provided to the Control Committee, the first 12 players in the FIVB O-2 Form will constitute the team.

**7.3 Registration Fee**

Each participating team must pay an entry fee of US\$750.00 (Seven Hundred Fifty Dollars) in addition to the payment of US\$500.00 (Five Hundred Dollars) that corresponds to the Anti-Doping test control fee.

7.3.1 This payment should be made throughout a certified check, made and payable to the order of NORCECA Volleyball Confederation or in cash. The Registration fee should be remitted together with the original of the FIVB O-2 Form before June 10, 2010 or during the team preliminary enquiry.

**8. Official Rules, Ball & Uniforms**

8.1 The **2010 NORCECA Men's Junior Continental Championship, U-21** will be played under the current FIVB rules at the time of the competition. All necessary interpretations are to be clarified during the Referee Clinic and/or the General Technical Meeting.

**8.2 Official Ball:**

The official ball will be the **Molten IV5XC**. NORCECA Confederation will provide to the Canadian National Volleyball Federation a total of 30 volleyballs Molten IV5XC.

**8.3 Uniforms:**

Player's uniforms should be in accordance with FIVB Official Rules. Each team should have available a minimum of two (2) sets of playing uniforms of different colors, one of which should be based colored white. The team Captain and Libero uniforms in case that its uniform is of different color and design from the rest of the team uniform, should be presented during the team preliminary inquiry to the Control Committee for inspection, verification and approval. The player's names and numbers on the uniforms must be the same as on the FIVB O-2 and O-2 bis Forms.

**8.4 Publicity on uniforms:**

Publicity on players' uniforms must be authorized by NORCECA previous to the payment of the established fee. These forms are available to be downloaded throughout NORCECA Confederation web page, [www.norceca.org](http://www.norceca.org).

**8.5 Dress code for officials on the bench:**

All Officials on the bench must be uniformed according to the dress code of the current FIVB Regulations. Those Officials that do not comply with the dress code established will not be allowed to seat on the bench.

## 9. Competition Format and Teams Distribution

- 9.1 The **2010 NORCECA Men's Junior Continental Championship, U-21** will be played under one of the following competition formats:
- a) With twelve (12) Teams Three (3) groups of four (4) teams each will be formed.
  - b) With eleven (11) Teams two (2) groups will be formed of four (4) teams each and one group (1) of three (3) teams.
  - c) With ten (10) Teams two (2) groups will be formed of three (3) teams each and one group (1) of four (4) teams.
  - d) With nine (9) Teams three (3) groups will be formed of three (3) teams each.
  - e) With eight (8) Teams two (2) groups will be formed of four (4) teams each.
  - f) With seven (7) Teams one (1) group will be formed with four (4) teams and one group (1) with three (3) teams.
  - g) With six (6) Teams two (2) groups will be formed of three (3) teams each.
  - h) With five (5) teams one group will be formed.
  - i) With four (4) teams one group will be formed.

### **Official Competition Schedule/Format**

- 9.2 According to the above Competition Formats, the **Official Competition Schedule/Format** of the Event must Pre-establish the Group distribution of teams and order of the matches to be played for the Preliminary Round, the distribution of teams and order of the matches to be played for the Qualification Rounds, the Quarter Final Round, the Semi Final Round and the Final Round.

### 9.3 **Quarter Final Round**

According to the established Competition Format indicated in 9.1 (a), (b), (c) and (d) above and the FIVB/NORCECA General Competition Regulations, for the Quarterfinal Round, the lowest ranked 1<sup>st</sup>. place team, based on the points ratio system of their Group Preliminary Round, will play the lowest ranked 2<sup>nd</sup>. Place team, and the highest ranked 2<sup>nd</sup>. Place team, based on the point ratio system of their Group Preliminary Round, will play the second highest ranked 2<sup>nd</sup>. Place team. (LR 1<sup>st</sup>. place team vs. LR 2<sup>nd</sup>. place team) and (HR 2<sup>nd</sup>. place team vs. Second HR 2<sup>nd</sup>. place team), winners will advance to the Semi-Final Round.

According to the established Competition Format indicated in 9.1 (e), (f) and (g) above and the FIVB/NORCECA General Competition Regulations, for the Quarterfinal Round, the second and third place teams of their Group Preliminary Round, will play each other as follow; (A-2 vs. B-3 and B-2 vs. A-3), winners will advance to the Semi-Final Round.

### 9.4 **Semifinal Round**

According to the established Competition Format indicated in 9.1 (a), (b), (c) and (d) above and the FIVB/NORCECA General Competition Regulations, for the Semifinal Round, the two highest ranked 1<sup>st</sup>. place teams, based on the points ratio system of their Group Preliminary Round, will qualify to the Semifinal Round and will play against the winners of the Quarter Final Round.

Within the possibilities, for the Semifinal Round, it must be avoided that teams from the same group play each other. In case that for the Semifinal Round, teams from the same group qualify, the match between the highest ranked team and the lowest ranked team, based on the points ratio system of their group preliminary round, will be repeated.

According to the established Competition Format indicated in 9.1 (e), (f) and (g) above and the FIVB/NORCECA General Competition Regulations, for the Semifinal Round, the first place teams of their Group Preliminary Round, will qualify to the Semifinal Round and will play against the winners of the Quarter Final Round. Within the possibilities, for the Semifinal Round, it must be avoided that teams from the same group play each other. In case that for the Semifinal Round, teams from the same group qualify, the match between the highest ranked team and the lowest ranked team, based on the points ratio system of their group preliminary round, will be repeated. (A1 vs. A3 or B1 vs. B3).

- 9.5 According to the competition format indicated in 9.1 (h) and (i) above and the FIVB/NORCECA General Competition Regulations, for the Preliminary Round, one Group will be formed to play a Round Robin. A Semi Final Round will be played according to the final ranking of the Preliminary Round, based upon the point's ratio system, 1<sup>st</sup>. place vs. 4<sup>th</sup> Place and 2<sup>nd</sup> Place vs. 3<sup>rd</sup> Place, the winners will advance to the Finals for the Gold Medal and the losers will play for the Bronze Medal.

## 9.6 Round Robin Ranking

The ranking of teams will be determined by the results of the matches on the basis of matches won and lost and according to the number of points gained among teams of the same group. The following points will be awarded per match to each team:

Match Won	=	2 points
Match Lost	=	1 point
Match Forfeited	=	0 point

## 9.7 Tie Breaking Procedure

In case of equality in the number of points gained by two or more teams, the tie will be broken by the point's ratio according to Article 8.3 of the FIVB Sport Regulations, with the following criteria in order of importance:

- A) **Point Quotient:** In case of equality in the number of points gained by two or several teams they will be classified in descending order by the quotient resulting from the division of all points scored by the total of points lost.
- B) **Set Quotient:** If the tie persists as per the point's quotient the teams will be classified in descending order by the quotient resulting from the division of the number of all sets won by the number of all sets lost.
- C) **If the tie continues as per the set quotient between two teams,** the priority will be given to the team which won the last match between them.
- D) **When the tie is between three or more teams** a new classification of these teams will be made taking into consideration only the matches in which they were opposed to each other.

## 9.8 Team Distribution:

For the **2010 NORCECA Men's Junior Continental Championship, U-21** teams will be distributed according to their position in the NORCECA Continental Ranking, as of January 1<sup>st</sup>, 2010, using the Serpentine system for their distribution as follows:

### **Group A**

1<sup>st</sup> Order NORCECA Ranking  
6<sup>th</sup> Order NORCECA Ranking  
7<sup>th</sup> Order NORCECA Ranking  
12<sup>th</sup> Order NORCECA Ranking

### **Group B**

2<sup>nd</sup> Order NORCECA Ranking  
5<sup>th</sup> Order NORCECA Ranking  
8<sup>th</sup> Order NORCECA Ranking  
11<sup>th</sup> Order NORCECA Ranking

### **Group C**

3<sup>rd</sup> Order NORCECA Ranking  
4<sup>th</sup> Order NORCECA Ranking  
9<sup>th</sup> Order NORCECA Ranking  
10<sup>th</sup> Order NORCECA Ranking

## 10. Rights of the Host Country

- 10.1 Further to 9.8 above, the host country has the right to choose the group for their National Team. The remaining teams will be distributed using the Serpentine System in accordance with their position in the NORCECA Continental Ranking and FIVB Ranking in case that no ranking points are available in the Norceca ranking, starting with the highest ranking team as head of Group A, B, or C. The host country has the right to choose one (1) match in the Competition Schedule of the Preliminary Round.
- 10.2 Once the Preliminary, Qualification, Quarterfinals, Semifinal and Final Round matches are established, the Canadian National Volleyball Federation will propose to the Control Committee the time and order of all matches to be played.
- 10.3 The host country will also have all other rights as established in the FIVB General Regulations.

## 11. Financial Responsibilities

- 11.1 The following will be the financial responsibilities of the Canadian National Volleyball Federation:
  - a) **Internal Transportation, lodging, and meals** for Control Committee, Referees and Team Delegations, from the date of arrival to date of departure.
  - b) **Medical Services:** First Aid Medical Service must be provided during the Competition. (International Medical Insurance is recommended for participating teams in order to cover the payment of the medical services required by the members of their delegation).
  - c) **Payment of Per Diem** to Control Committee Members, Technical, Support Staff and Referees, according to what has been established by NORCECA Volleyball Confederation as follows:

- **US\$100.00** (One Hundred Dollars) per day, two days before and one day after the competition for the President, Members of Control Committee, Medical Delegate, Photographer, Members of the Appeal and Referee Sub-Commission including one Member in each Sub-Commission from the host country, according to the established Regulations.
- **US\$150.00** (One Hundred Fifty Dollars) per day, two days before and one day after the competition for the Press Delegate, VIS Delegate and Competition Director.
- **US\$100.00** (One Hundred Dollars) per day, two days before and one day after the competition to be paid to the, FIVB Referee, International Referees and Candidate to International Referee or Continental Referee per participating teams. Maximum participating Referees 14 including the host team referee, neutral and reserved local referee.

**NOTE 1:** The payment of Per Diem for the Members of the Control Committee, Competition Director, Press Delegate, Medical Delegate, VIS Director, Technical, Support Staff and participating Referees must be covered before the conclusion of the Preliminary Round of the competition.

**NOTE 2:** The payment of Per Diem to local officials, technical and support personnel, including the members of the Control Committee of the host country, medical and local press delegate, is to be made in accordance with the established agreement between the National Volleyball Federation or Local Organizing Committee and the person contracted for the required services.

**NOTE 3:** For the payment of the Per Diem for the FIVB Referee, International Referees and Candidate to International Referee or Continental Referee, the Organizing Committee is responsible to cover 50% and the remaining 50% is to be covered by the Referee's participating National Federation of origin and/or the National Federation that the Referee represent, according to the decision of NORCECA Board of Administration meeting in May, 2009. All participating NF must cover the Referees per diem during the Team Preliminary Inquiries.

d) The Canadian National Volleyball Federation must cover the following financial responsibilities toward NORCECA:

- **US\$7,500.00** (Seven Thousand Five Hundred Dollars) to cover the payment of the hosting fee of the Event.
- **50%** of participating teams Registration Fee. For this event in particular and due to the category (Junior) of the event, the registration fee for participating teams will be US\$750.00 (Seven Hundred Fifty Dollars). 50% of the registration fee of participating teams will be paid to the Canadian National Volleyball Federation and the remaining 50% of the registration fee corresponds to NORCECA.

## Sponsorship and Marketing

- **US\$7,500.00** (Seven Thousand Five Hundred Dollars) of Marketing and/or sponsorship of Local and TV transmissions, as well as for the Marketing rights of Local Sponsorships is to be paid to NORCECA, establishing a minimum fee of US\$750.00 (Seven Hundred Fifty Dollars) for each sponsor promoting their products inside or outside the Main Competition Venues.

**Note 1:** Government, State and/or Provincial economical support and/or contribution will not be considered as sponsorship, commercialization and/or marketing.

**Note 2:** The Confederation reserves the rights to allocate the following official NORCECA's sponsors banners in the court: NORCECA, FIVB, MOLTEN, SPORTSCOURT.

**Note 3:** NORCECA Volleyball Confederation , reserves the rights of the international sponsorship, as well as, the international marketing that correspond to the radio, TV Broadcasting and internet .

**Air Fare** the Canadian National Volleyball Federation and/or Organizing Committee will be responsible to cover the payment of the air fare (economical class) for Control Committee Members and Neutral Referee.

11.2 The following are the financial responsibility for participating National Federations:

- a) To remit a letter confirming the participation of their National Team to the NORCECA and Canadian National Volleyball Federation before April 2, 2010.
- b) Payment of Entry Fees of US\$750.00 (Seven Hundred Fifty Dollars) in addition to the Anti-Doping fee of US\$500.00 (Five Hundred Dollars) before June 10, 2010.
- c) Remit together with a copy of the FIVB 0-2 Form, one (1) team photo and individual photos (size 2x2) of all members of each participating team delegations (players, officials, doctors, journalists and referees) before June 10, 2010.
- d) Be responsible for all other additional expenses of their delegation that may apply.
- e) Payment of international transportation, as well as airport taxes.
- f) To present the following documents in the Preliminary Inquiries;
  - O-2
  - O-2 bis
  - M-3
  - L-1
  - M-8 (if necessary)
  - Publicity Form (if necessary)

- The passports of all players
- Color copy of all players passports
- Captain's and Libero's uniforms

## **12. Sanctions and Complaints**

### **12.1 Complaints:**

- a) All complaints must be presented in writing to the Control Committee. The procedure established to present a complaint must be according to Article 9 of the FIVB Sports Regulations. Complaints will be solved according to the FIVB General, Sports and Rules of the Games in force.
- b) Complaints related with a technical issue (violation of the FIVB Rules of the Games) must be solved by the acting Control Committee of the match where the violation of the Rules of the Games has been verified. The procedure must be in accordance with the FIVB Sports Regulation (**Judges Conferences**). Violation of the Rules of the Games must be claimed, by the affected team, during the development of the match in course and must be solved during the match by the Control Committee.
- c) All complaints and appeals not related with a technical issue and/or violation of the Rules of the Games must be presented in writing to the Control Committee President within 60 minutes after the conclusion of the match. Complaints and appeals must be presented with a deposit of US\$500.00 cash; if the complaints and/or appeals proceed, the deposit will be reimbursed. The Control Committee President must announce the verdict within 12 hours after the presentation of the complaint and/or appeal.

### **12.2 Sanctions:**

For this competition the following sanctions have been established:

- a) Negligence to provide the FIVB O-2 Form by the deadline established, will apply a sanction of US\$500.00.
- b) Negligence to provide the Registration Fee by the deadline established, will apply a sanction of US\$500.00.
- c) The non fulfillment of Article 8.3 of these Regulations, corresponding to the uniforms of Participating Teams, in accordance with the FIVB Official Uniform Regulations, will apply to a US \$3,000.00 sanction.
- d) All sanctions established by the FIVB Constitution, Code of Conduct, Administrative, Financial, Sport, General Regulations and Complementary Statutes would be applicable.

## **13. Referees**

- 13.1 Each participating National Federation must nominate (mandatory) one (1) Referee from one of the following categories:
  - a). FIVB
  - b). FIVB International Referee
  - c). International Referee Candidate
  - d). Continental Referee

13.2 **NORCECA'S President** or his **Representative**, with the advice of NORCECA's Refereeing Commission, will evaluate the nomination of the Referees presented by each participating National Federation to approve or reject them.

13.3 **Other Officials:**

13.3.1 According to the FIVB General Regulations and considering that the **2010 NORCECA Men's Junior Continental Championship, U-21** is a Continental Event, approved by FIVB as a Qualification Tournament to the 2011 FIVB Men's Junior World Championship, U-21, the Control Committee (Refereeing Sub-Commission and Appeal Sub-Commission) will be assigned by NORCECA's President and must be composed by representatives of the National Federations affiliated to NORCECA whose representatives are members of the NORCECA Executive Committee / Board of Administration, NORCECA'S Sports Organizing, Technical , Refereeing ,VIS, Press and Medical Commission.

13.3.2 Line judges, scorekeepers, statisticians, VIS, ball retriever, sweepers, scoreboard operators, announcers and other supporting personnel shall be presented by the representative of the National Volleyball Federation to the Control Committee President and/or his representative for approval.

13.3.3 The National Volleyball Federation will present these personnel to the Control Committee during the Refereeing Clinic, for evaluation and approval.

13.3.4 The Refereeing Sub-Commission will assist the Control Committee with officials and support personnel and will be responsible for their supervision.

14. **Training Facilities**

14.1 The Host National Volleyball Federation or Local Organizing Committee will provide training facilities with appropriate conditions for the daily training of the participating teams, for at least 1.5 hours from their arrival until the end of the competition.

14.2 Each Team will have a minimum of one training session of 1.5 hours, in the official competition venue prior to the event.

15. **Security**

The National Volleyball Federation and/or the Local Organizing Committee must guarantee the security of the participating team delegations, from their arrival until their departure, including hotels, main competition venues, training venues, during official matches as well as for their internal transportation.

16. **Accreditation**

The National Volleyball Federation and/or the Local Organizing Committee must provide the correspondent accreditation to all participating teams, NORCECA's Officials, Referees, National and International Technical and Support Staff. Accreditations must be designed according to the standards established by NORCECA Confederation and must include the logos of FIVB, NORCECA, the National

Volleyball Federation, title of the competition, photo and function of the accreditation holder.

<b>FIVB</b>	This accreditation is reserved strictly for FIVB officials.
<b>NCC</b>	This accreditation is strictly reserved for NORCECA Volleyball Confederation Officials.
<b>CC</b>	This accreditation is reserved for Control Committee members assigned to the competition.
<b>NF</b>	This accreditation is reserved for the members of the Executive & Board Administration of the Host National Federation.
<b>OC</b>	This accreditation is reserved for the members of the Organizing Committee of the hosting country of the event.
<b>G</b>	This accreditation is reserved for all governmental officials of the host country of the event.
<b>D</b>	This accreditation is reserved for accredited members of the Diplomatic Corp. of the host country of the event.
<b>VIP</b>	This accreditation is reserved for special guests.
<b>TP</b>	This accreditation is reserved for the technical personnel and staff assigned to specific areas of the organization of the event. (VIS (statisticians), Line Judges, Scorekeepers, Scoreboard Operators)
<b>SP</b>	This accreditation is reserved for the support personnel assigned to specific areas of the organization of the event. (ball retrievers, sweepers, flag holders, announcers, venues working staff)
<b>P</b>	This accreditation is strictly reserved for accredited Journalists, Press, Host Broadcaster, International Press Agencies and Local Press Agencies.
<b>A</b>	This accreditation is strictly reserved for participating players. (Athletes Only). Players accreditation must include the competition number of the player as well as, the anti-doping test control code to be provided by NORCECA for the anti-doping protocol process according to the WADA/FIVB Protocol Regulations.
<b>TS</b>	This accreditation is strictly reserved for the staff of participating teams. (Team Staff: Team Manager, Head Coach, Assistant Coach, Registered FIVB Team Doctor, Therapist and Team Statisticians).
<b>S</b>	This accreditation is strictly reserved for security personnel only.
<b>R</b>	This accreditation is exclusively reserved for participating International Referees.
<b>MD</b>	This accreditation corresponds to the medical personnel assigned to the event.

## **17. Medical Services**

- 17.1 The National Volleyball Federation and Local Organizing Committee will provide first aid medical services during the competition.
- 17.2 All team delegations shall be responsible for their own medical expenses. (It is recommended that all participating teams be provided by their own medical insurance).

## 18. Awards:

The first three (3) ranked teams will be awarded as follows:

- 18.1 **1<sup>st</sup> Place:** Gold Medal and Team Trophy ( Qualifies to the 2011 FIVB Men's Junior World Championship, U-21)
- 18.2 **2<sup>nd</sup> Place:** Silver Medal and Team Trophy (Qualifies to the 2011 FIVB Men's Junior World Championship, U-21)
- 18.3 **3<sup>rd</sup> Place:** Bronze Medal and Team Trophy ( Qualifies to the 2011 FIVB Men's Junior World Championship, U-21)

### 18.4 Individual Awards:

The Control Committee will present individual awards to the following players, taking into consideration the final result of the VIS System. The awards to be presented are:

Best Spiker	Best Defense
Best Blocker	Best Setter
Best Reception	Best Libero
Best Server	Best Scorer
Most Valuable Player (MVP)	

- 18.5 The libero players will compete among each other for the best libero award of the event. Additionally the libero players will be able to opt for the best defense and reception award of the event. If a libero player obtains the three above indicated awards, he has an option to the Most Valuable Player Award, (MVP) of the event.

- 18.6 The Most Valuable Player, MVP, of the event will be awarded to the player that, from among the two finalist teams that will compete for the first place, Gold Medal Match of the event, will register the highest amount of points scored and accumulated in attack, block and serve during the competition, according to the final results of the Volleyball Information System, VIS. Also, the libero player will be able to opt for the Most Valuable Player award of the event, if obtains the three awards indicated in the above article (best libero, best defense and best reception) and his team is in the final match for the first place, Gold Medal of the event.

The Control Committee members will be responsible to evaluate the Most Valuable Player of the event, taking as reference his individual performance according to the statistics of the Volleyball Information System, VIS.
